7.6.1: Clerk's Annual Salary Review – Currently paid SCP 27, £15.00 per hour, 11 hours per week, =£165.00. (*NALC recommended rate for SCP 27 in 2023/24 £18.53 per hour, 11 hours per week,* = £203.83). Plus £600 per year office rental and energy allowance and £50.00 per month telephone and internet package.

NALC recommended rate for SCP 27 in 2024/25 £19.20 per hour, 11 hours per week, = £211.20. Discussions ensued and The Clerk recommended a freeze on his salary for this year as he feels the job is well paid. This was then proposed by Councillor Keeble, seconded by The Chairman, ALL AGREED.

The Chairman thanked the Clerk for agreeing to hold his salary at this level and for all his hard work throughout the year.

9.1.1: Lloyds Bank changes to Account Status – The Treasurers account is to change to a Community Account with a monthly fee of £4.25 plus variable fee for every transaction. (100 electronic transactions will be free).

The Clerk has looked into changing banks, but it looks like all banks will be doing this shortly.

9.1.2: Domain change – We are being encouraged to change to a .gov.uk domain for our website, this will cost £105 plus VAT plus £55 every two years.

Councillor Reynolds:

Rubbish pile at 6 Bucklawren Road – Has now cleared.

Christmas 'Light Up' – Saturday 7th December with refreshments and entertainment from the group NobZ. All welcome.

Councillor Keeble:

Parking Fines at Millendreath – A lady has contacted Councillors Keeble and Toms regarding an unfair parking fine whilst staying at a villa in Millendreath, the lady paid the fine, however when she investigated it further, she was not even on site on that day, she has contacted Premier Parking and the British Parking organisation to protest. Days later Premier Parking cancelled the fine and refunded the lady, stating the cameras were malfunctioning on that day – how many more people got unfairly fined? Valley Resorts were also contacted, however, to date no response has been received. The clerk to talk with Councillor Lawes on his return.

Councillor Lankston:

Nothing raised.

Vice Chair Powley:

Drain outside No 7 Holland Road – Still bubbling with fresh water, it looks like a burst pipe underground. The Clerk to report again.

The Chairman:

Nothing raised.

County Councillor Armand Toms:

Central Government Funding for the County – Over the last 12 months County Councillor Armand Toms has been looking into the funding received from Central Government, Cornwall received £22 per head of population less than similar parts of the UK, rural communities on average receive £34 million less that urban areas. Social Care is also underfunded in comparison to other parts of the Country, County Councillor Armand Toms has asked for a meeting with all concerned to discuss the underfunding for the country.

Polperro Road, Looe Closure – Attending a meeting next Friday, to discuss the effect on the town, 8 businesses are closing up for the winter this year which is unheard of and a sign of how seriously trade is being affected.

Land Train accident at Tregoad – Pleased to report everyone has left hospital now, no life changing injuries however the incident has caused much trauma and will take some time to recover from. The H&S Executive are investigating the incident.

Vote of Confidence regarding the leader of Cornwall Council – Has taken place and the vote was lost, and the leader remains in her position.
